

REGULAR MEETING MINUTES

Regular Meeting Minutes March 15, 2023

The Directors of the Colorado County Groundwater Conservation District met on March 15, 2023 at 7:00 p.m. in the District Office at 910 Milam Street, Columbus, Texas.

President Wegenhoft declared a quorum present and convened the meeting at 7:38 p.m.

Regular Meeting Minutes and Permit Hearing Minutes dated February 15, 2023 were reviewed and approved.

GM Brasher presented a Class B Operating permit application submitted by Tourrat Investments, LLC. Director Mahalitc moved to approve a three-year permit for 10 ac-ft. and require a meter. The motion was seconded by Director Parks and carried unanimously.

GM Brasher gave an update on annual water usage reporting. Annual Water Use forms were due by January 31, 2023. All forms were received except for Black Gold Ranch (Dean Robichaux). Mr. Robichaux has failed to submit his water usage after multiple requests. Director Mahalitc moved to access a \$250 fine if the requested information is not received by March 31, 2023. Beginning, April 1, 2023, additional fines will be assessed every two weeks if information is not received. The motion was seconded by Director Moulder and carried unanimously.

GM Brasher reported work is continuing on draft rules for proposed Management Zone 2 in the northern part of the county where groundwater is less abundant. He will invite the District's attorney, Monique Norman, to the next board meeting to further advise on the matter.

GM Brasher reported on the following matters:

GM Brasher gave an update on an illegally drilled well owned by Alva Mabel Hernandez Lara. A State of Texas Well Report was received for the new well drilled by Zavala Drilling and a Plugging Report was received for the illegal well. GM Brasher will request permission to perform an inspection.
